

RE: PLEASE REVIEW PROGRAM -- RE: Targeted and detained in a U.S. military program based on my bioelectric or bioelectromagnetic fields

To whom it may concern,

I am requesting an evaluation and Intelligence Oversight Inspection into the incident/program described below to see if it complies with the laws, executive orders, regulations, and directives governing intelligence and intelligence-related activities along with potential violations of the Foreign Intelligence Surveillance Act (FISA), Executive Order 12333, and other applicable laws and directives. In pursuant to DoD Directive 5148.13 I am also reporting Questionable Intelligence Activities and Significant or Highly Sensitive Matters as described below in my original email. Please review and STOP IMMEDIATELY the incident below of a U.S. person in a NSA/INSCOM/SOCOM program to see if it complies with the laws, executive orders, regulations, and directives governing intelligence and intelligence-related activities.

I. Physical Torture

Directed energy beams and tasks that were excessively and frequently used on the following areas enough to be described as torture. These areas were targeted more than normal and more than needed; often in the magnitude of hundreds of times more than normal.

- 1.) Sphenoid
- 2.) Atlas vertebra
- 3.) Front of neck
- 4.) Back of neck

- 5.) Complete spinal column
- 6.) Right frontal lobe
- 7.) Right arm (hand, forearm and bicep)
- 8.) Lower back/lumbar
- 9.) Right side of face (Sinus, eye socket, zygomatic bone)
- 10.) Compression of midbrain
- 11.) Compression of cerebral cortex
- 12.) Sedation
- 13.) Psychological effects generated by the physical beams
- 14.) Occipital muscles
- 15.) Masseter and pterygoid muscles
- 16.) Tightening of cremaster muscle and superficial inguinal ring

II. Psychological Torture

Techniques, training and technology employed excessively & frequently enough on the following areas to be described as torture. These areas were targeted more than normal and more than needed; often in the magnitude of hundreds of times more than normal.

- 1.) Voice-to-skull (cranium communication) usage
- 2.) Voice-to-skull content (word spoken, conversations, sentiment)
- 3.) Scripts (scripted dialogue)
- 4.) Life changes (bankrupt 7 times, relocated 4 times, job loss, lifestyle changes (loss of full-time work, homelessness [lived out of car & parks]), loss of wages, opportunity cost [education, hobbies], loss of health benefits, mounting debt [student loans, credit cards], selling of personal items)
- 5.) Threats of life, extortion into breeding program and sexual arrangements, continued engagement, torture, and harassment
- 6.) Multiple people/teams engaging with him overtime (~80 people to-date)
- 7.) The "Program" or designed process, roles, tests and timelines they the military personnel/private contractors have been putting him through

RE: Targeted and detained in a U.S. military program based on my bioelectric or bioelectromagnetic fields

To whom it may concern:

I am a U.S. citizen who finds himself targeted by an illegal, covert, high-tech, psychotronic, government, gang stalking, no-touch torture program which leaves the least physical evidence of any wrong-doing. I did not consent to being in this U.S. military program which has controlled and consumed 6 years of my life and has taken away my civil liberties, constitutional rights, human rights, and bodily autonomy. They started targeting me in 2017, secretly surveilling me first unannounced without me ever being able to detect that my innermost details of my life are being collected and analyzed. Then they started to engage with me directly in 2019 with directed energy beams and have kept me in this military program for 7 years because I declined to participate in a breeding program. I'm unable to return to a normal life or an office job due to this ordeal and I face ongoing abuse, harassment, and torture due to the military's unethical, unprofessional, and legal failings on top of their unwillingness to disengage, respect my constitutional rights, and sovereignty of body and mind.

Army's INSCOM (United States Army Intelligence and Security Command), the NSA (National Security Agency), and other military intelligence units run a program

that goes beyond the bounds of the law by targeting unwitting citizens based on their bioelectric or bioelectromagnetic fields. NSA and Army's INSCOM, and its counterparts in the U.S. Space Force, Navy, Air Force, and Marine Corps and the Central Security Service(CSS) are all involved in Signals Intelligence (SIGINT) which has evolved into a science of decoding electromagnetic fields (EMF) in the environment for national security and tracking purposes. Signals Intelligence is based on the fact that everything in the environment with an electric current in it has a magnetic flux around it which gives off EMF waves even an individual's bioelectric or bioelectromagnetic fields. INSCOM, the NSA, and CSS have developed proprietary advanced equipment which can remotely analyze all objects whether man-made or organic that produce electrical activity including humans. The human brain and heart emits a unique frequency that identifies you among a crowd of people or from family members in a home. Some individuals who emit a particular bioelectromagnetic field are targeted more than others.

Two sources of strong bioelectrical activity in humans are the heart and brain with the spine acting as a conductor inducing a bioelectromagnetic field. A stacked completed spine induces the strongest field with the least amount of noise, loss, and distortion. My spine was stacked and I reached the thalamus in 2020 and over the years since I have had the NSA, a number of INSCOM units, U.S. Space Force Deltas, other units listed at the bottom of this letter and their contractors abuse, harass, and torture me while refusing to disengage and leave me alone. It's been a daily ordeal since 2020 and an hourly ordeal since January 2023 to today. At the same time individuals connect to me remotely to recondition their energy and participate in the harassment. I've been "the sun", an individual with more energy added to them by the military, five times to date; in 2021, Jan 2022-Aug 2022, Jan 2023 - July 2023, Aug 2023 - Jan 2024, and Feb 2024 - Aug 2024. I was dropped by Space Force to my lowest energy levels in January of 2024 yet the military has refused to disengage and wants to keep targeting me. I have also placed my thalamus 28 times within the third ventricle; smashed the thalamus 10+ times within the third ventricle; reached the dome 11+ times; reached the brow 19 times; freed all vertebra of my spine, and have been a star six different times. Haven't I done enough to get out of this Army(NSA/INSCOM) program? Additionally, one of the military personnel said I was used for another Army program without my consent from 2011-2015 where I reconditioned 12,000 people's energy and helped to clear their spines. From 2017 to now I've helped recondition the energy of 28,000 people bringing the total from 2011 to now to 40,000 people. The military and its contractors have now placed my thalamus up high near the forehead squeezed in between the hemispheres in front of the infundibulum and over the optic chiasma & optic nerve and insist that they will continue the abuse until I submit to a breeding program. Don't I have a right to refuse medical treatment grounded in autonomy and informed consent? I do not want my thalamus up there. I want my thalamus in the third ventricle and my cervico thoracic junction corrected, which I had fixed on the 9th of May 2024. Additionally, I want the military to leave me alone.

Technology known as Voice-to-skull(V2K) is being used for traceless mental harassment and communication. Harassers distract, interrupt, deceive, and slow my normal thinking by beaming in abusive voices or music into my head constantly by-passing my ears. Voice-to-skull is how the U.S. military communicates with me while I'm in this program along with social media sites such as x.com (@QThebob), anonup.com (@QueenEsther), and instagram. Technology called Remote Neural Monitoring is used to track me and non-invasively monitor audio-visual information in my brain. The military and its contractors have established taps into my visual and auditory cortex. They can send images directly to the visual cortex, bypassing the eyes and optic nerves. This is all done with no physical contact nor consent from me. Using this the harassers can view all my innermost thoughts on a screen,

as clearly as one reads a newspaper. My eyes become a live camera for the military personnel and contractors. Whatever I view is recorded on the perpetrators' computer or viewed by the perps' brains using a brain-to-computer and brain-to-brain interface. All these technologies are no-touch, covert, and are remotely operated therefore they leave minimal evidence if at all thus making all available laws ineffective and powerless to help the American who is targeted.

INSCOM, NSA, SIGINT units, and their counterparts have the ability to remotely and non-invasively monitor information within my brain including thoughts, reactions, motor commands, auditory events, and visual images by digitally decoding the evoked potentials or electro-magnetic emissions emitted by my brain. I am perfectly monitored from a distance as well as harassed, abused, and tortured. Everything happening inside my mind is monitored by the military. EMF Brain Stimulation works by sending a coded and pulsed electromagnetic signal to trigger evoked potentials in my brain, thereby creating sound and visual images in my brain's neural circuits and can be used to transmit information as well as nervous system messages to me. It is all at the touch of a button from anywhere, traceless, just by using my unique brain signature to target me anywhere. These satellite-based technologies result in gross by-passing of fundamental human and civil rights such as personal privacy, property, health, safety, data security, family security, etc.

The U.S. military uses directed energy beams to destroy my psychology and tighten and restrict me, putting me in a prison of my own body. The directed energy beams have a physical affect and are similar to physical restraints like straight jackets, straps, belts, or shackles but invisible and traceless and the perpetrators refuse to turn them off and disengage. The military and their contractors insist they stay engaged with me until I submit to a five year breeding program. Because of this the perpetrators have me in a situation where they feel they can do whatever they want to me and get away with it. They do things to me that are not part of stacking one's spine, which was done in 2020. They have also targeted and caused harm to members of my family including my 70 year old mother. They targeted her brain using directed energy beams damaging her and causing a negative impact to her psychology and have done this 24 different times turning her into a fearful, worrisome, negative and argumentative individual. They've also targeted my brother, his wife and their children with the directed energy beams. If I am in a house then anyone else in the house can be targeted according to the military and has been so. My livelihood has been threatened, forced relocation five times and forced to quit two jobs and live in my car. My career has been systemically made to vanish due to this. I haven't been able to return to my career since the individuals behind this based on their own admission got me laid off. They make it difficult to obtain and hold down a job as they have harassed and tormented me while at work. I've maxed out three credit cards and have been bankrupt seven times as I deal with these last 6 years. They are blocking and filtering my emails, targeting me with voice-to-skull technology, hitting me with directed energy beams daily, monitoring my biometrics, online traffic, mobile phone calls, financial records, and using remote neural monitoring. They use directed energy beams to manipulate the body remotely from a distance and cause physical harm and injury. I have had denial of service attacks launched against me, computer hacked, and key loggers deployed. They have also wirelessly tapped into my computer, hacked into my mobile phone, turned on and off alarm clocks, rebooted it to safe mode, and recorded conversations. When I sleep, pre-packaged dream sequences are routinely downloaded to my brain like video pushed into my mind and harassers interact with me while I am laying in bed in an almost hypnagogic state. They routinely wake me up in-between 12:00am and 3:30am and remotely sedate me using an electromagnetic beam stimulating the thalamus and they won't allow me to get enough sleep during the day or night. These artificial, remote, hypnagogic dream sequences serve to harass me, extract information, or observe my reactions to

certain scenarios while also creating an ongoing state of deprived sleep. They justify my abuse, harassment, and torture because I am "here", they say, within this program yet it is them that keep me in the program and keep psychologically and physically harming me.

The U.S. military has used voice-to-skull technology, approximately 18-22 hours per day on average, covert surveillance abuse, sleep deprivation, remote neural monitoring, cyberstalking, chat bots, and directed energy beams to psychologically and physically abuse and torture me. With the directed energy beams I've had them cause pain in my body and limbs along with the inside of my skull targeting various parts of my brain (cerebrum, optic nerve, cerebellum, pineal, midbrain, brain stem etc.). They anesthetize me for the pain, cause severe ear barotrauma, compact or jam the brain stem into the mid-brain, visual distortions, sleep deprivation, insomnia, swelling, body temperature changes, severe muscle tightness by abusively "sowing me up" or tightening and restricting my body, acute pain, and ongoing aches all throughout the body and skull. I have had violent and non violent images involuntarily sent to my mind pushed to my visual cortex, severe blisters on the back of my head, back pain, targeting of the heart muscles, tightening of the atlas vertebra, sphenoid bone, and occipital muscles, tightness all through out my body, chest restriction, severe headaches, spinal distortions(misplaced vertebrae & cervico thoracic junction), joint mobility issues and pain. I have also dealt with hives, neck routinely and excessively tightened thousands of times, lumbar spine flattened with hips forced into a posterior tilt, hips excessively tightened, decreased thyroid function, depression, perceptions and moods altered, motor control impacted, routinely sedated, cortisol levels elevated, sympathetic nervous system over stimulated, negative psychological changes, incessive dialogue piped into my head along with music which often loops. Additionally, I have had pre-package hypnagogic dreams induced, been routinely threatened, intimidated, cursed at, belittled, suffered from psychological trauma, depersonalization, loss of autonomy over my mind and body, and more. They take an approach where they tighten a specific muscle or muscle group until it is in pain and then add energy to the muscle, muscle group, spine or body to increase the pain and use the level of energy to modulate the pain to cause a higher or lower level of pain.

I do not like what the U.S. military is doing to me nor turning me into. They use software to run tasks or processes remotely that instruct the directed energy beams to engage with me and have a physical or psychological affect. All the while the perps and military continue to abuse and harass me from the moment my eyes open up till the moment I close them and sleep. Even in bed in the privacy of a home, something I once took as a safe retreat, the contractors and military control and invade my sovereignty of body and mind. Hypnagogic dreams, remote sedation, voice-to-skull, and directed energy beams are what they use on me while I sleep. They use "scripts" or pre-crafted or ad-lib psychological theater to create a rollercoaster ride of emotional states combined with the affects of the directed energy beams to bring me up emotionally, creating feelings of hope and friendliness, and then drop me into states of depression while using EMF brain stimulation to push suicidal images into my mind once the depression they created sinks in. This cyclic up and down process slowly denigrates an individual. Voice-to-skull is used to perform the scripts, converse, or "test" for a trait or response. This act of testing alone is used to justify the abuse and harassment; "where're testing" they say. They will pass me from one team to the next to continue the constant and endless harassment and abuse in order to avoid any sympathy or historical understanding of me to develop. This approach of passing me around to different teams throughout the day is a form of abuse itself in-bedded in the structure of the program that dehumanizes me. Space Force also used directed energy weapons on me in retaliation for speaking out about my ordeal causing a series of six red track marks along my right heel which swelled, itched, burned, and caused throbbing pain along with

localized swelling of the ankle. The six track marks eventually blistered.

I am reaching out to you for assistance in getting out of this military program, escaping the illegal surveillance, abuse, harassment, and torture. I would like to get my life back and Constitutional rights restored. The military has expressed the desire to keep me in this situation till the end of the year or longer and squeeze me financially and extort the precarious situation I am in. They repeatedly insist I participate in a breeding program. They talk about me as if I am property and they are my handlers, the perps, military personnel, and military contractors which communicate with me via voice-to-skull. They want to continue selling access to me and then push me into a breeding program and then plan and control my future. The perpetrators say, "You're not supposed to be here..", "Thank you for your service", "you shouldn't even be here", and "I'm sorry" while the teams constantly argue with each other. They are also telling me that this experience will end "when we say so" while some voices are saying that I should be freed and left to recover on my own. They say they are keeping me in this program because people are paying to keep me in this program. I achieved green & gold in January 2024, completed the square twice in 2023 & May 2024 which is the spine, and completed the circle numerous times from 2023-2024 which is the endocrine system. I am now in a situation where this Army run program is having difficulty wrapping up and my involvement in it concluded. I was told that I would be taken out of this program numerous times, August 2022, August 2023, August 2024 and October 2024. They have also commented that I could have been out from this program at the end of 2022 or the end of 2023. They've also said that I have gone through seven rounds of this (2020, 2021, Jan 2022-Aug 2022, Sept 2022-Dec 2022, Jan 2023-Jul 2023, Aug 2023-Jan 2024, Feb 2024-Aug 2024) with a round being the time it takes to stack one's spine but they still will not disengage. The military personnel use contractors, a number who are psychopathic and pathological liars and do not care, to dehumanize and mischaracterize me while prolonging my involvement so that they can vilify me, condone the treatment they give, and push me into a five year breeding program. The contractors are paid well for this by the military and are used to harass me since the military is not allowed to harass a civilian directly. The military personnel and contractors use the names Scott, Mark, Amanda, Matthew, Melissa, Josh, and Tina and have also mentioned these number multiple times 562-229-8252, 253-851-7654, 857-334-9190, & 852-567-1885. I've reported the matter to the Criminal Investigation Division in January 2024 at JBL McChord and Special Agent Avram Nord commented "maybe someone is playing mind games with you" and when I called the 22nd Signal Brigade inquiring about voice-to-skull I had a military service-member comment "how do you enjoy the program". I also had an individual who called himself Leonard Devara call my mother and brother multiple times from number 571-456-6899 falsely impersonating an Army CID federal agent who began to intimidate, threaten, harass, and extract information from my family (18 U.S. Code § 912 Falsely Impersonate a Federal Officer).

These criminal activities of the U.S. military are a domestic threat to the U.S. Constitution. These government employees work under a sworn oath, defending the U.S. Constitution against all enemies, foreign and domestic. The NSA, a number of INSCOM units, Space Force Deltas, other units listed at the bottom of this letter, and their contractors are prohibited by law from targeting and harming U.S. citizens within U.S. borders under International Human Rights treaties, the Geneva Convention, the United Nations Convention, Nuremberg Code, the U.S. Constitution, U.S. Code, Civil Rights laws, Common, Civil & Tort Law, U.S. Military Code of Justice, U.S. Supreme Court precedents, Department of Defense and National Security Directives, and Executive Orders.

Any assistance in escaping this military program or having them disengage would be appreciated. They are controlling my life and ruining it; robbing it of time.

Taking away my life, liberty, and pursuit of happiness. A tax-payer funded terrorism and liability for the military. They weaponize technology such as voice-to-skull, remote neural monitoring, EMF brain stimulation, directed energy beams, drones, and space-based delivery platforms and virtual realities to create a high-tech torture program aimed at Americans based on a person's bioelectric or bioelectromagnetic fields. My account within these virtual realities supposedly has an account creation date of 2017. That's when my involvement in this program started. My physical health, hygiene, peace of mind, career and social credibility, family, friends, and other relationships; all of these have gotten seriously downgraded and systematically made to fade out via the above program. What is worse in this world than your body, brain, and mind getting hacked and harassed covertly and illegally. Please investigate this. This military program has not received any medical or legal review nor does it have any proper oversight or policing. I was targeted by the military in 2005 & 2006 at the age of 24 & 25 (directed-energy beams tightened my chest & rib cage), 2009 at the age of 28 (directed-energy beams flipped my spine into a "C" shape by moving vertebrae), and 2012 at the age of 31 (directed-energy beams damaged my rotator cuffs in my shoulders) and now I'm going through this, which started around 2017-2019 and it is now 2024 and I am 43 years old. It has to stop.

This is a Civil Rights Issue (i.e. the 14th Amendment Substantive Due Process) the government should not interfere in my life and a 14th Amendment protective class issue. An individual's bioelectric or bioelectromagnetic fields should be a protected class as is race, sex, ethnic minorities, disability status, etc. are under the 14th Amendment to the U.S. Constitution and Civil Rights Act of 1964. Which ensures equal treatment and opportunities for all citizens and prohibits government from denying an individual's life, liberty, or property without due process and guarantees equal protection under the law. The U.S. military should not be discriminating, spying, or harming someone based on an individual's bioelectric or bioelectromagnetic fields. The situation is getting out-of-hand and has been mismanaged and mishandled creating an environment of illegal behavior on top of fraud, waste & abuse with a failure to correct course and end the engagement.

My family member earned the Congressional Medal of Honor during WWII on August 15, 1944 during the invasion of Southern France as part of Operation Anvil/Dragoon. My father was a Marine and a policeman. I was nominated to West Point. My mother is a teacher, my brother is a lifelong EMT/Firefighter and my three uncles served in the Army and Navy and both grandfathers served in the Navy and Air Force. I come from a military family and my family has served this country well. I am being treated as a Non-Investigative Subject yet I have never been accused of any crime though I am continuously subjected to illegal surveillance, harassment, abuse, and torture. I suggest you investigate this situation immediately and end promptly. I no longer want to be targeted by the U.S. military and this engagement should be over. This is still happening to me and they are making it difficult for me to reach out for help by blocking my inbound and outbound emails.

- On 5/10/24 I was directed by the Assistant Attorney General of Washington State

to report this matter to the FBI.

- On 5/22/24 the Office of the District Attorney of Colorado encouraged me to contact law enforcement.
- On 6/18/24 the US Army's Assistance and Investigation Chief of Medical Readiness Command East Office of the Inspector General recommended contacting the FBI.
